Advertisement for Development Opportunity and Request for Qualifications (RFQ) for Project Developer for UCR Health Outpatient Pavilion Project uBuy Project Number: RFQ-FY2017-372

The Request for Qualifications (RFQ) referenced above has been released (in electronic format only)

Overview of Opportunity

The University of California, Riverside's Capital Asset Strategies Department, within the Planning and Budget Division, is seeking Statements of Qualifications and project concepts from experienced real estate development and financing teams ("Developers"). The selected Developer will undertake the development, financing, design, construction, and management of an approximately 300,000 sq. ft. medical office building and any necessary parking facilities on land owned by the University of California, Riverside ("UCR" or "University"). The University intends to enter into a negotiated agreement with the Developer selected through this process for the development of the site. The University's land would be leased to the selected Developer under a long-term ground lease, and a portion of the space in the building would be leased-back by the University for both student and community health care uses. The Developer will also have the opportunity to incorporate other closely related uses. This Development Opportunity is referred to hereafter as the "UCR Health Outpatient Pavilion" or the "Project."

Location

The proposed Project is envisioned to be located at the University's west campus area, near the intersection of University Avenue and Iowa Avenue (1150 University Avenue), an approximately 4.8- acre site bordered by University Avenue to the north, and Everton Place to the south. Developers experienced with medical facilities are preferred, and will need to demonstrate their qualifications to undertake projects of their identified conceptual type and size. A select group of respondents will be placed on a "short list" of potential Developers. and be provided with a future Request for Offers.

- 1. Experience with formulating and implementing successful Public-Private Partnership development projects of similar scope and scale
- 2. Qualifications and experience of assigned Key Personnel
- 3. Project concept and approach
- 4. Financial capacity
- 5. Ability to access external financing and/or equity capital
- 6. Responses to required disclosures regarding litigation, arbitration and equal employment opportunity policy

Required Agreements

- 1. Ground Lease
- 2. Space Lease
- 3. Project Development Agreement
